Car Showroom Appeal

A successful re-negotiation of a car showroom assessment due to floor area discrepancies, resulting in total savings for the client of £188,500.

Contractors Basis Valuation

By correcting the property facts relied upon by the Valuation Office Agency in the valuation of a waste transfer station, we saved the occupier £100,000 in business rates payable.

Wedding Venue
